AGREEMENT OF BORROWER'S RESPONSIBILITY**

- \_\_\_\_\_ I hereby apply for an Enoch Pratt Free Library Card and agree to abide by all Library regulations.
- \_\_\_\_\_ I agree to return all Library materials that are entrusted to me, making every effort to return them by the day they are due.
- \_\_\_\_\_ I understand there is a daily fine for all materials checked out and not returned by the due date.
- \_\_\_\_\_ I understand the usual borrowing period is three weeks, but some materials may have shorter borrowing periods.
- \_\_\_\_\_ If I default on the return of Library materials entrusted to me, I agree to pay all applicable fines, plus the cost of collection and the processing fee charged on unreturned materials.
- \_\_\_\_\_ I understand that my Library record will be turned over to a collection agency if my bill reaches \$25.00.
- \_\_\_\_\_ I will notify the Library of any change of address or telephone number.
- \_\_\_\_\_ I understand I am responsible for material borrowed on my lost or stolen Library card until the loss is reported to the Library.
- \_\_\_\_\_ I understand that the Library utilizes an Internet filter on all workstations.
