_____ I hereby apply for an Enoch Pratt Free Library Card and agree to abide by all Library regulations.

_____ I understand there is a daily fine for all materials checked out and not returned by the due date.

_____ I understand the usual borrowing period is three weeks, but some materials may have shorter borrowing periods.

_____ If I default on the return of Library materials entrusted to me, I agree to pay all applicable fines, plus the cost of collection and the processing fee charged on unreturned materials.

_____ I understand that my Library record will be turned over to a collection agency if my bill reaches \$25.00

_____ I will notify the Library of any change of address or telephone number.

_____ I understand I am responsible for material borrowed on my lost or stolen Library card until the loss is reported to the Library.

Material borrowed via Marina can be returned to any Pratt Library. Out-of-state interlibrary loan items must be returned to the library where it was borrowed from.

One renewal, and only one, is permitted on renewable items.

First-time borrowers are limited to two (2) books, or one (1) DVD, or one (1) videocassette tape, or one (1) audiocassette tape, or one (1) compact disc.
