#### IV. Chair's Remarks

Dr. Mychelle Farmer began her remarks by informing the Board of how excited she is about the Pratt's future. As of late February, Baltimore has the lowest incidences of COVID-19 for the entire state of Maryland. Truly, this reflects Baltimore City's collective effort to stop this lethal pandemic. This spring, the Pratt will have a lot to celebrate! Dr. Farmer informed the Board that the Pratt has a new website, it was previewed in December. Dr. Farmer reminded the Board that

it's Baltimore's best Board and to remain ready to listen, learn, and lean in. Dr. Farmer informed the Board of new developments such as developing the pathway for Emeritus membership for Board members desiring to accept this designation. This plan is under construction with the help of the Governance Committee and with a small group of Board members who expressed an interest to assist with the process. Dr. Farmer and the Governance Committee will provide details on the criteria for Emeritus at the Annual Board meeting in June. Dr. Farmer informed that Board that the Pratt is also developing a Diversity-Equity-Inclusion Committee (DEI), and this group is also in the process of developing its goals and terms of reference. This will be an independent committee, and at the present time, the following Board members are participating: Ms. Sarah Brandt, Dr. Beulah Sabundayo, Ms. Patricia Lasher, Ms. Kate Rawson Powell, Mr. Alex Koff, Mr. Vernon Reid, and Dr. Mychelle Farmer. The DEI Committee will open new avenues of communication between the Pratt staff and the Board, consistent with the Pratt Library Strategic Plan. Dr. Farmer hopes to promote Board engagement as part of a Board learning agenda. It will also promote a strategy for Board members to talk to one another and to learn from one another as the Board "Listens, learns, and leans-in." Dr. Farmer concluded her remarks by sharing a poem entitled *The First Book* from Rita Dove, one of her favorite American poetesses. It reflects the wonder of discovery through reading and learning.
