THE PRATT IS ALWAYS HERE FOR YOU



I hope this finds you well and staying safe. Over the past few months we have all experienced varying degrees of uncertainty and anxiety as we face the compounding factors of a global health pandemic that has left many of us at home and a racial reckoning that has made us confront some brutal truths about our society. It can be overwhelming, particularly for those of us with young children. As a mother, I have had to ask myself: How do I explain this moment? That we need each other to move forward and change, all the while recognizing the importance of social distancing. At those moments, I remember why I became a librarian. I remember why I chose to come to Baltimore and lead the Enoch Pratt Free Library. I remember that even apart, we are together.

This summer, the Pratt looks very different than it ever has in its nearly 140-year history. The twists and turns of this past year have rivaled the most imaginative books on our shelves. Yet several fundamental things have not changed at the Pratt: our deep commitment to the Baltimore community; providing access to essential resources; and advancing equity, diversity, and inclusion in all that we do. Indeed our founding mission to serve “all, rich and poor, without distinction of race or color” is more vital than ever as our society moves towards long-needed and necessary reform.

In February the world as we knew it changed. The Pratt Library was able to rapidly respond to serve the Baltimore community at a time of crisis and need. We immediately focused on our electronic resources, pivoting our programs to virtual formats and adding a wealth of online databases for job seekers, teachers, families, and students of all ages. Our nimble response has made the following, and so much more, possible:

- In an effort to bring free internet to those who need it, we boosted Wi-Fi signals at eight branches and started lending Wi-Fi hotspots to customers. In addition, our mobile units are working in neighborhoods without internet to provide free Wi-Fi connection for up to 60 personal devices.
- Kids and teens at home are participating in a reimagined digital Summer Challenge. Virtual programs include theater, STEAM, fashion & design, yoga & wellness, and entrepreneurship.
- The Library’s workforce development initiatives are more important than ever as unemployment claims have risen to record levels. Our Job & Career Center and the Mobile Job Center are transitioning their efforts to virtual programs that provide comprehensive web guides for local businesses, tax-filing, and unemployment services.

I am proud of the Pratt’s response and of our staff’s commitment to the city and state we serve. We also realize that there is still work to be done. We continue to partner with government officials, nonprofit leaders, healthcare experts, workforce specialists, our incredible boards, our customers, and so many others to expand our offerings and help ensure we are moving Baltimore towards a more equitable state. There are innovative offerings on the horizon — including a new online high school degree program, the Library of Things that will provide hotspots and devices for loan, and more — that we believe will continue to empower and enrich our city.

As I reflect on this past year, I remember the joy our community experienced as we opened the doors of the Central Library after a four-year renovation, the excitement of children re-visiting the iconic fish pond, and the enthusiastic welcome we gave speakers like Spike Lee, Dan Rather, and Colson Whitehead. Programs like these may not be possible right now, but we do have some exciting things in store for the fall!

I am humbled by the incredible support you and others in our shared community provide to make our work possible. It’s because of your generosity that we are able to reach those who need us the most, even while we wait to re-open our doors!

Baltimore, we are here for you. Thank you for being there for us!
