Abstract	The Carroll County Historical Records contain a variety of records that document the slave trade in Carroll County, Maryland as well as naturalization, immigration, and citizenship of slaves released from bondage.

The records include the following: ownership and release of slaves, naturalization, immigration, and citizenship. The records are stored in the library vault, which requires an appointment to retrieve records for examination.
